## **Acknowledgement of Admission to St. George's University**

Students at St. George's University are expected to conform to all the University's rules and regulations as published in the Student Manual, adjust to the cultural customs of the University's host nations, comply with the laws and requests of the host nations' governments, comply with the laws and requests of the faculty and administration of St. George's, and maintain a respectful attitude towards the University administration and faculty. Students should expect to devote full time to studies. Therefore, no outside employment or activities of any kind that, in the opinion of the University, might conflict with these educational responsibilities will be permitted.

Please note that the University reserves the right to change any provisions, offerings, requirements, or fees at any time within a student's period of study. A student's acceptance into the School of Medicine is granted upon the presumption by the Faculty Student Selection Committee that:

1. All courses currently being taken by the applicant will be completed prior to registration.
2. All statements made by the applicant during the admission process, whether oral, written, or in submission of academic documentation, are true and correct.

If it is subsequently discovered that false or inaccurate information was submitted, or if any other information comes to the attention of the University which raises a concern regarding a student's appropriateness for acceptance into the School of Medicine, the University may nullify a candidate's acceptance or, if the student is registered, dismiss the student.

By signing this document, you are considered a student of both Northumbria University (NU) and St. George's University (SGU). SGU-NU students are issued a Confirmation of Acceptance for Studies (CAS) by Northumbria University which is used to apply for a [UK Student Visa](#). Please note that [Immigration Health Surcharge](#) (IHS) fees will be payable during the visa application process with costs based on the total duration of visa sponsorship as outlined below:

- In the case of students entering the SGU/NU MD Track 6, UK Student Visa + 1 year of Basic Principles of Medicine) in the UK and 1 year (Year 2 Principles of Clinical Medicine) in Grenada.

- In the case of students entering the SGU/NU MD Track 5, UK Student Visa sponsorship will last a total of 3 years – 2 years (1 year of preclinical Sciences + 1 year of Basic Principles of Medicine) in the UK and 1 year (Year 2 Principles of Clinical Medicine) in Grenada.
- In the case of students entering the SGU/NU MD4, UK Student Visa sponsorship will last a total of 2 years – 1 year of Basic Principles of Medicine in the UK and 1 year (Year 2 Principles of Clinical Medicine) in Grenada.

Students who study part of their SGU program at NU will have the opportunity to complete a UK degree award (Bachelor of Medical Sciences). Students who successfully completed the UK degree award can apply for the [UK Graduate Visa](#) (subject to successful application). Please note that applications for the Graduate Visa must be made from the UK and can only be submitted by students who hold a valid UK Student Visa at the point of application.

Northumbria University is the sponsor for your UK Student Visa. It is important you are aware of your responsibilities and how your visa status impacts on your future options. Students can only transfer to Grenada for the second year of the MD4 program for Principles of Clinical Medicine and maintain UK student visa sponsorship by Northumbria University.

Where a student transfers their studies to Grenada at any point other than Year 2 Principles of Clinical Medicine of the MD4, their UK student Visa sponsorship will be withdrawn. Students who have their UK visa sponsorship withdrawn will not be eligible to reapply for a UK student visa should they wish to return to NU to complete their degree. Only students who complete the NU Bachelor of Medical Sciences Ordinary Degree will be eligible to apply for the 2-year UK Graduate Visa which can be used for clinical rotations in the UK. Please carefully consider your study and travel plans to avoid a negative impact on future options. Please also review the [tuition fee refund policy](#) and the [re-sit fee policy](#).

Students who attend the Grenada campus (do not complete the Bachelor of Medical Sciences Ordinary Degree at NU) will be subject to a successful visa application through SGU-sponsored student visa for UK clinical rotations for a maximum of two years depending on previous (if any) time spent in the UK during the duration of study at SGU.
